Proclamation

WHEREAS; from drinking, bathing, and household use to agriculture, food production, and industrial processes to hunting, fishing, and outdoor recreation, water is a fundamental part of the everyday lives of Wisconsinites and serves as the basic support system for all life on the planet; and

WHEREAS; bodies of water such as lakes, rivers, streams, and wetlands provide critical habitats, flood protection, and opportunities for fishing, boating, swimming, and other recreational activities that improve the quality of life in Wisconsin; and

WHEREAS; healthy waters are recognized by the Native Nations that call Wisconsin home—including elders, Tribal councils, water walkers, and conservation professionals—as a critical foundation for maintaining cultural traditions and practices, sustaining hunting and fishing territories, and retaining a bright future for future generations; and

WHEREAS; with its bountiful natural resources, which include 88,000 miles of rivers and streams, approximately 800 miles of Great Lakes shoreline, more than 15,000 inland freshwater lakes, five million acres of wetlands, and 1.2 quadrillion gallons of groundwater, the state of Wisconsin is committed to upholding and defending clean water initiatives across the state, including efforts to protect drinking water from PFAS, lead, nitrate, and other harmful pollutants in the state's water supply; and

WHEREAS; Wisconsin is home to more than 11,000 public water systems—the largest number of any state—serving as the drinking water source for about three-quarters of Wisconsin residents, with the majority of those who do not utilize the state's public water systems relying on private wells as their water source; and

WHEREAS; enshrined in the state's constitution and supported by a history of legislation and legal decisions regarding the conservation of the state's waters, the Public Trust Doctrine establishes that the people of Wisconsin have the right to access, use, and protect the waters of the state; and

WHEREAS; in 2025 the Year of the Kid, the state of Wisconsin remains committed to fighting for greater protections for water standards in the state and working to get PFAS, lead, and other harmful contaminants out of the state's water supply to ensure the well-being of kids, families, and communities across the state; and

WHEREAS; this week, the state of Wisconsin joins dedicated advocates and organizations in celebrating the importance of clean water and reaffirms its commitment to protecting recreational waters, investing in conservation, and working to ensure that people in every corner of the state can drink straight from their taps without fear of contamination;


NOW, THEREFORE, I, Tony Evers, Governor of the State of Wisconsin,
