

WHEREAS; with 1.28 million cows and approximately 5,300 dairy farms, Wisconsin has a long and proud tradition as “America’s Dairyland,” and ensuring the long-term success of the industry is vital for the state’s economic future and for the future of the farmers and farm families that have been the backbone of this state for generations; and

WHEREAS; according to the United States Department of Agriculture, in 2024 alone, Wisconsin’s dairy farmers produced more than 32 billion pounds of milk—accounting for more than 14 percent of all milk produced in the United States; and

WHEREAS; Wisconsin is also well known for its world-class cheese production, and the state’s nearly 1,200 licensed cheesemakers produce a quarter of the nation’s cheese, ranking Wisconsin as the nation’s top cheese-producing state; and

WHEREAS; driven by a vast network of dairy farmers, equipment manufacturers and technicians, cooperatives, veterinarians, construction companies, milk haulers, processing plants, genetics and software companies, and more, Wisconsin’s dairy industry creates a wave of economic impact that is felt in every corner of the state, generating more than \$52 billion to the state’s economy and supporting more than 120,000 jobs each year; and

WHEREAS; the state’s dedicated dairy farmers and their families, processors, and distributors play an important role in Wisconsin’s collective heritage, culture, and identity, and it is essential that the state continues its work to make sure that dairy farmers and all those that make up the agricultural industry have the support and resources to thrive; and

WHEREAS; dairy farmers continue to show immense strength and resilience, and Wisconsin is proud to continue to support efforts to bolster their success with investments in research to expand the industry, additional resources for dairy processors, and efforts to bolster dairy exports, ensuring Wisconsin continues to be well-positioned for future opportunities and to be a global leader in the dairy sector; and

WHEREAS; this month, the state of Wisconsin reaffirms its commitment to serving as a steadfast partner to farmers, the agricultural industry, and rural communities, joins all Wisconsinites in honoring dairy farmers and all members of the state’s dairy industry for their continued hard work and contributions, and encourages Wisconsinites in every corner of the state to support their local dairy farmers and producers by buying locally made products, championing the work of local dairy farms, and uplifting local leaders in this vital industry;
